3. i) In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1 (Part A and B) were submitted to the Ministry for an appraisal by the State Level Environment Impact Assessment Authority (SEIAA) and State Level Expert Appraisal Committee (SEAC) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.

ii) The State Level Expert Appraisal Committee (SEAC) examined the proposal in its meeting held on **11.06.2026** and based on the information furnished by the proponent, the presentation made by the Environmental Co-ordinator of M/s. Southern Enviro Engineers Pvt. Ltd., Hyderabad, the committee recommended the proposal for grant of EC under the provision of EIA Notification, 2006 and as amended thereof.

iii) The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

iv) The SEIAA has examined the proposal in its meeting held on **30.06.2026** discussed in detail and noted that the SEAC reviewed the proposal and that the proposal was earlier returned in present form as the committee observed that the proposed site was overlapping with the neighboring proposal. Now, the proponent has applied for fresh EC duly submitting the NOC's from the neighboring land owners whose lands were overlapping with the proposed site. The SEAC verified the NOCs submitted by the proponent and opined that the proposal may be considered as they have obtained NOC from the neighboring land owners.

In view of the above and based on the recommendations of SEAC, approved the project for Environmental Clearance for instant proposal of **M/s. Svadha Projects LLP**, under the provision of EIA Notification, 2006 and as amended thereof and with stipulation of specific, additional and general conditions as detailed in Annexure (1).

v) The details of the project as submitted by the project proponent is enclosed as Annexure (2).

vi) The Ministry reserves the right to stipulate additional conditions, if found necessary.

vii) The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.

**General Instructions:**

- (a) The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of MoEF&CC/SEIAA website where it is displayed.
4. (b) The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
- (c) The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
- (d) Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project

proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.

(e) Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.

(f) The Regional Office of this Ministry shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.

(g) Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
