Sr. No	Queries	Response to queries raised
1	Insurers requested for the Bank's employee-wise data (Grade and Class wise) highlighting the following – (a) Sum assured under the existing cover, (b) Sum assured under the entitled cover This data was primarily sought for the purpose of underwriting the differential cover amount.	As already indicated in Annexure II of the RFP, data will be shared with the participants with the following details: •Date of Birth •Age •Class •Grade •Gender •Existing Cover •Entitled Cover •Differential cover to be insured. <u>Data will only be shared upon submission of Non-Disclosure agreement, as specified in Annexure V.</u>
2	Clarification sought regarding Annexure I (Technical evaluation), Point No. 3 of the RFP, whether the names of clients/companies need to be specified in cases where the premium exceeds ₹2 crore.	The insurers must only submit details regarding the number of group term life insurance policies with premium above ₹2 Crore. However, the same shall be certified by an auditor.

The intending participants were advised that no deviation in RFP terms and conditions will be accepted by the Bank and all bids have to strictly adhere to conditions mentioned in the RFP.
