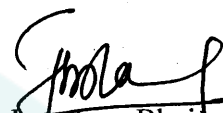

On the basis of site visit report, our proposal was listed in SEAC II, the Environmental Clearance issued to us do not have any mention as regard clearance given for the consent to establish nor the consent conditions as mentioned in OM.
